## Section 4: First-Aid Measures

### Description of first aid measures

- Inhalation**
- IF INHALED: If breathing is difficult, remove person to fresh air and keep at rest in a position comfortable for breathing. Call a poison control center or doctor for further treatment advice.

## Section 5: Fire-Fighting Measures

### Extinguishing media

- Suitable Extinguishing Media**
- LARGE FIRE: Water spray, fog or regular foam.  
SMALL FIRES: Dry chemical, CO<sub>2</sub>, water spray or regular foam.
- Unsuitable Extinguishing Media**
